Bookings

Payment

Payment shall be made in full, without deduction, within 30 days of the date of the booking, notwithstanding the date of invoice or date of travel.

Default

In the event that the Customer is in breach of any of the terms of this agreement, and in particular in breach of the requirement to pay within thirty days of the date of booking all credit shall be withdrawn and all sums shall fall immediately due for payment, whether invoiced or not. No further credit shall be extended.

Interest

The Late Payments of Commercial Debts (Interest) Act 1998 as amended (“the Act”) shall apply to this Credit Agreement. Interest shall be paid on all outstanding debts at the rate of 8% above the Bank of England base rate, or at such other rate as the Act shall allow.

Generally

Direct Freight Ltd shall have the right to refuse credit or to disregard references without declaring the reason why, at its sole discretion.
